**Ben Simms****CEO, Tropical Health Education Trust (THET)**

Ben joined THET ([www.thet.org](http://www.thet.org)) in 2015 bringing 25 years' experience of working internationally with a focus on health and disability. At THET he leads an organisation that is pioneering a health partnership approach to the training of health workers across 30 countries in Africa and Asia. Health partnerships harness the skills of staff from the UK National Health Service in ways which bring mutual benefit to all involved, a vision of co-development that speaks to the new era of the Sustainable Development Goals. He currently serves on the Steering Group of the Uganda-UK Health Alliance and the Programme Advisory Boards for the Health Education England Improving Global Health Through Leadership Development programme, and the Royal College of Obstetricians and Gynaecologists. Ben has an MSc in Development Management from the Open University and an MA in History from Edinburgh University.

**Barb Jacobson****Co-ordinator of Basic Income UK, Basic Income Earth Network (BIEN)**

Barb Jacobson is an advice worker at a small central London charity which helps people with benefits, housing and debt. She has been active in community organising since 1982, focussing on women's health and housing issues. A co-ordinator of Basic Income UK, she is on the board of Unconditional Basic Income Europe, a network of organisations and activists in 25 countries across the continent.

**Dr Waheed Arian****Founder and CEO, Arian TeleHEAL**

Kabul-born Dr Waheed Arian came to the UK as a refugee, with just a few words of English, and yet went on to gain degrees and awards from Cambridge University, Imperial Medical School and Harvard Medical School and now practices at Aintree University Hospital. He established a charitable trust called Arian Tele-heal, [www.arianteleheal.com](http://www.arianteleheal.com), a charity with 100 volunteer medics who advise colleagues in Afghanistan and other countries using social media or other every day technologies. This pioneering telemedicine scheme has been credited with saving the lives of many patients. Dr Arian has been recognised with the UN Global Hero Award (2017), the Health Service Journal Highly Commended Rising Star Award (2016) and the Presidential Award from the President of Afghanistan. Dr Arian was also appointed as a NHS Innovation Fellow in 2017. His successes and story have been covered by numerous media organisations around the world.

**Dame Yvonne Moores DBE****Chair, Wessex Global Health Network**

Dame Yvonne Moores was England Chief Nursing Officer and Director of Nursing at the Department of Health in 1992–99, and previously CNO for Scotland (1988-92) and for Wales (1982-88). She played a key role as an adviser to governments on policy and quality issues. Dame Yvonne was a Pro-Chancellor at BU from 2006 to 2013 and a Non-Executive Director at Poole Hospital for eight years, as well as the Vice-Chairman of the Board for four years. She is Patron and Trustee of the Poole Africa Link which is supporting the development of healthcare in South Sudan and Uganda, through education and training of doctors, nurses and midwives and in taking vital medical equipment to Wau Hospital. Dame Yvonne is Chair of the Wessex Global Health Network Steering Committee.

**Professor Rob Middleton****Director of Orthopaedic Research Institute (ORI) Bournemouth University**

Professor Rob Middleton is a Consultant Orthopaedic Surgeon specialising in hip replacement procedures. At Bournemouth University he is Professor of Orthopaedics and Head of the Orthopaedic Research Institute (ORI) [www.bournemouth.ac.uk/ori](http://www.bournemouth.ac.uk/ori) and is recognised both nationally and internationally for his work. ORI works with a range of global stakeholders, institutes and industry partners, aiming to improve patient outcomes both locally and nationally. Having always been involved in research and improvement in Orthopaedics, it has been a long term aim of Professor Middletons' to introduce the benefits of robotic surgery to patients.

**Professor Edwin van Teijlingen****Professor of Reproductive Health, Bournemouth University**

Edwin is Professor of Reproductive Health and joint director Centre for Midwifery, Maternal & Perinatal Health (CMMPH) at Bournemouth University in the UK. His background is in the social sciences. He has conducted over two decades of research into maternity care and midwifery in the UK and in Asia (Bangladesh, India & Nepal). He has published widely on important aspects of maternal health, including both theoretical and practical aspects. At various UK universities he has successfully supervised over 25 PhD students to completion and examined nearly 35 PhD candidates, including some in Finland and Denmark. He is a member of the NMC (Nursing-Midwifery Council) Midwifery Thought Leadership Group in the UK. He is also visiting professor at the University of Nottingham in the UK and two universities in Nepal.

**Professor Anba Soopramanien MD PhD FRCP (Lon)****Consultant in Spinal Injuries and Rehabilitation Medicine**

Anba is a Visiting Professor at CoPMRE, Faculty of Health & Social Sciences, Bournemouth University. He has worked in France and the UK. In Pakistan and Romania he worked with the International Red Cross Movement (ICRC and IFRC), helping to organise spinal units and limb-fitting centres. To help offer neuro-rehabilitation services in Mauritius, he has set up NEURAM FOUNDATION [www.neuram.org](http://www.neuram.org). He is Honorary Secretary of the e-Health and Telemedicine section of the Royal Society of Medicine and carries research on Digital Health. He is an executive member of the World Federation of Neuro-Rehabilitation and the African Spinal Cord Injury Network.

**Millie Clive-Smith****Chief Operating Officer, Co-Founder Entia Ltd**

Millie Clive-Smith is an entrepreneur who works at the intersection of healthcare, technology and design. In 2014, Millie co-founded Entia, a medical device start-up which uses new technology and a user centred design process to improve quality of life and health outcomes for people with chronic conditions. Her work has been exhibited in the Design Museum, London. Millie has previously worked for internationally renowned design consultancy MAP, and was awarded a studentship from the Royal Commission for the Exhibition of 1851 for her double masters in Innovation Design Engineering from the Royal College of Art and Imperial College London. She also has a BSc in Physics and Astrophysics.

**Dr Fleur Kitsell****Health Dean, Health Education England (Wessex)**

Dr Fleur Kitsell qualified as a physiotherapist in July 1982, worked clinically in the NHS for six years, then worked in the university sector for 13 years. In 2007 she became Head of Innovation and Development in the NHS South Central SHA, developing and implementing schemes to prepare individuals for senior leadership roles. Since then she has worked in various roles with responsibilities for Research, Innovation and Improvement and is now the Associate Director, Workforce Transformation for HEE (Wessex), and leads various multi-professional initiatives across Wessex, the South of England and nationally. She remains interested and committed to education and developing people. One focus of her work is creating opportunities for NHS staff to learn and implement improvements – whether this be in the NHS, or on an overseas placement opportunities through the IGH programme – and through so doing learn effective personal leadership behaviours and skills.

**Professor Paul Thompson MD FRCP****Visiting Professor, Bournemouth University**

Paul moved from the Royal London Hospital to Poole Hospital as Consultant Rheumatologist in 1991, building the small service to win Hospital Doctor Rheumatology Unit of the Year 2000. He was Director of CoPMRE at Bournemouth University for ten years and Scientific Advisor to Osteoporosis Dorset, the charity he founded in 1992. He retired in 2015 spending a year sailing to the West Indies. Paul has two children, lives in rural Dorset and spends his free time sailing. He joined the Poole Africa Link team ([pooleafricalink.org.uk](http://pooleafricalink.org.uk)) in 2017 and is working to strengthen links between Bournemouth and Lira Universities.





**Mr Tony Markus**

Consultant Maxillofacial Surgeon and Visiting Fellow, Bournemouth University

Tony Markus, formerly Consultant Maxillofacial Surgeon at Royal Bournemouth and Poole Hospitals, specialised in cleft and craniofacial deformity and craniomaxillofacial trauma. Over the last 30 years, he developed a number of cleft centres in India and more recently in Nepal. He established Future Faces ([www.futurefaces.org.uk/about/trustees](http://www.futurefaces.org.uk/about/trustees)) a charity whose aim is to train and support young surgeons and allied professionals from around the world to competently manage people with clefts and craniofacial deformities in safe, accessible surroundings and become self-sustainable.

Professor Psychiatric Social Work, FHSS, Bournemouth University

Colin is Research Professor Psychiatric Social Work, Faculty Health & Social Sciences and Emeritus Professor, School of Medicine, University of Southampton, reflecting his cross-disciplinary approach. Recent publications, with BU colleagues, include British Journal Cancer; British Journal Neurosurgery; British Journal Social Work; Child Abuse Review; Japan Journal Medicine, Psychological Medicine and Public Health. His Acta Neurologica Scandinavia identified a hidden neurological epidemic - his Children & Society found Britain has third worst relative poverty, fifth highest child mortality and lowest funded health in Western world. He tries not to be controversial, but it's inconvenient facts that embarrass British and American Governments.
